Incarcerated Applicant

Affidavit for Issuance of Marriage License to One Party

If either party is incarcerated in a prison within Nevada, the incarcerated applicant must complete the attached Affidavit for Issuance of Marriage License to One Party. Incarcerated applicants must include their **inmate number.** The incarcerated applicant's signature must be witnessed by a prison official, such as the chaplain, warden or other prison employee.

A copy of the <u>Nevada Offender Tracking Information System Offender Detail Record</u> must be attached to the Affidavit. The Offender Detail Record may be obtained from the Nevada Department of Corrections' web site at: <u>www.doc.nv.gov</u>. Select "Inmate Information" from the menu.

Per NRS 122, applicants for a marriage license must present acceptable identification (ID). A list of acceptable ID may be found at www.clarkcountynv.gov/depts/clerk. Select "Marriage Licenses."

The following must be presented to the Clerk at the time of issuance of the Marriage license:

- Completed Affidavit, attached
- Copy of Offender Detail Record
- Acceptable identification (ID)

NOTE: If either party is incarcerated in the **Clark County Detention Center**, the Detention Center requires a **court order** before a marriage ceremony may take place. Parties in this circumstance, who wish to marry, are responsible for filing the appropriate paperwork to obtain a court order. Parties may wish to contact an attorney for assistance.
